3. Port of Morrow Report on Grant Expenditures through March 2024

A Motion to approve the consent agenda was made by JD Tovey, second by Kelly Doherty. Motion Carried.



#### **New Business:**

- 1. Letter was read by Greg Smith for Teara Ferman with CTUIR on Recovery of Artifacts.
  - Mr. Puzey shared that Greg Smith is a strong director and should be able to act on items like this without board authority.
  - Motion to act on this letter by Jeff Wenholz, 2<sup>nd</sup> by John Shafer. Motion carries.
- 2. Greg Smith shares financial obligations the CDA has including the South Oregon Trail and Explosion site expenses, security costs, etc. Greg asked the board to allow CDA staff to negotiate on 100 acres to a perspective company that we have been working with over the last couple of years. He proposed pricing the 100 acres at 60-70 thousand per acre for a \$6 million profit.

John Shafer asked if the board would rescind the vote that was made last month and that without the rescinding of the vote, the county should be off the hook for any of those costs.

JD Tovey request CDA staff to create an operating budget.

Greg Smith shared that staff is trying to figure out how to budget when there is no revenue coming in.

Kim Puzey suggested CDA staff create a budget demonstrating what the budget would look like if it was split five ways or two ways.

Kelly Doherty shared that the Port Board Commission has also been talking about needing a budget from the CDA.

Jeff Wenholz shared that financial responsibility should be placed on the owners of the land.

Greg Smith shared that the CDA understands the need for a budget, but without income and revenue coming from the property, budgeting becomes very difficult.

Kim Puzey asked what the expenses are and what could the revenue bring.

Greg Smith shared that the federal grant will stair step down over the next three years and federal funding will be decreasing.

Joe Taylor shared that since the transfer of land has not yet gone through to the ports, the CDA is still in charge of the 100 acres and would oversee the sell/lease of 100 acres.

Kim Puzey asked if the Oregon Trail is still a 5-member obligation, or will that cost go to the Port of Morrow as they are the owner of the property?



JD Tovey and John Shafer shared that we have known about these obligations for months.

JD Tovey requested a 5-year budget showing the stair step down process from the grant.

Greg Smith said that the budget is brought forward every year in the grant application. We have obligations that must be met per our grant and the longer we continue to drag these obligational costs, we might not be able to meet those again.

JD Tovey requested a 5-year strategic budget.

Greg Smith advised that the CDA has traditionally operated on a one-year budget.

John Shafer shared that we have a fractured board right now and asked the board to rescind the vote.

Greg Smith shared that the financial issue is very significant and needs additional public input. He suggested moving the discussion of the vote to a future meeting.

JD Tovey shared that for the record the board did not have the same courtesy at last month's vote. Greg Smith advised saving that discussion for a future meeting.

Kim Puzey asked CDA staff to provide two budgets for the upcoming expenses. One budget demonstrating the two Ports covering the expenses and a budget demonstrating all five CDA partners covering the expenses.

John Shafer asked for a special meeting to rescind the vote.

Greg Smith shared the obligation to have the Oregon Trail design and build completed by September and the funding will be needed to get it done.

John Shafer again asked to have a special meeting to rescind the vote.

Kim Puzey expressed that he has no intent of rescinding the vote.

John Shafer asked Kim Puzey if he felt the vote was legitimate.

Kim Puzey shared that he did.

John Shafer asked CDA Staff if the CDA attorney had shared their thoughts on the vote?

Greg Smith shared that upon request he would forward an email from the attorney containing a letter.



John Shafer requested to be forwarded the letter from the attorney.

#### **Old Business**

1. PLA CDA and CTUIR CDA has now paid the Land Division Permit with Umatilla County Planning Dept. as of 4-16-2024. CDA is working towards the transfer of the property to CTUIR.

#### **Discussion Items:**

Public Comment Period: Joe Taylor shared that putting CDA Board meetings on a regular schedule would be preferred even if the meeting doesn't fit all board member's schedules.

Greg Smith shared that we have financial obligations and timelines that have to be met.
