### **EXECUTIVE SESSION**

Representatives of the news media and designated staff and other persons shall be allowed to attend the executive session. Representatives of the news media are specifically directed not to report on any of the deliberations during the executive session, except to state the general subject of the session as previously announced. All other members of the audience will be asked to leave the room or the CDA board may adjourn to another meeting room. The public virtual Zoom Meeting link will be closed during the executive session as permissible executive session meetings are not subject to HB2560.

No decision will be made in this executive session. At the end of the executive session, we will return to the open meeting and Zoom link session and welcome the audience back into the room in-person or virtually if Zoom is available and open the public meeting.
